The Commission is deducted the next day after the day when the transaction was opened. The commission from the table above is not applicable for day trading.

1. RallyTrade has the right to change this table of commissions and introduce new commissions/eliminate already existing commission, upon informing the Client according to the provisions stipulated in T&C
2. In case of Italian Equities CFD (.IT) there is an additional daily trading fee: 0.12% multiplied by net transaction value (purchase value – sell value) for particular instrument on a daily basis. If net transaction value is lower than 0 or no transactions will be executed during a day, the fee will be not charged.
